2024 National, State and Local REALTOR® Association Dues Schedule

All Payments Are Made ONLINE Only via your NABOR Invoice.

REALTOR MEMBERSHIP: Currently licensed real estate agents must file an application in order to join a local board, pay all appropriate fees, and completed new member orientation/Code of Ethics course, when applicable. Annual REALTOR Association (National, State and Local) Dues are \$500, pro-rated monthly. MLS services cannot be obtained until all requirements are met. Upon completion of all requirements, a new REALTOR® member is entitled to voting privileges in the Board and access to all of the association services. Dues and fees paid are non-refundable. NSF checks/denied credit are assessed \$25, per attempt to collect. Late Fees may be assessed to past due invoices. **All dues/fee payments must be done only via NABOR invoice. Invoices may be paid through Visa, Mastercard, American Express or electronic check.**

Each *new Agent/Appraiser Trainee* pays a one (1) time: **\$75 NABOR (local) Application Fee, Plus a \$50 LR (State) Application Fee**

Each *new Designated REALTOR®/Certified Appraiser* pays a one (1) time: **\$250 NABOR (local) Application Fee, Plus a \$50 LR (State) App Fee**
